Introduction

This Progress Report is for the period 1 July 2024 to 31 December 2024 under *Tasmania's Third Family and Sexual Violence Action Plan* 2022-2027: Survivors at the Centre.

Following a review of reporting needs undertaken in early 2025, a new six-monthly reporting cycle has been implemented commencing in 2024-25 and will continue until the end of the Action Plan in 2026-27. This change aims to provide more regular, consistent and targeted data to meet the needs of key stakeholders of Survivors at the Centre, and support Tasmania's reporting against the National Plan to End Violence against Women and Children 2022-2032.

Tasmanian Government departments will report at six-month intervals on their action progress. This streamlined approach will improve data quality and strengthen transparency and accountability to the Tasmanian community and sector stakeholders. The work and achievements during this period are critical steps in advancing our collective commitment to reducing family and sexual violence and supporting victim-survivors across Tasmania.

Achievements: 1 July 2024 - 31 December 2024

The following achievements occurred during the six-month reporting period, demonstrating the progress across the four key priority areas.

Partnership and transformation



Third Arch Centre to open in the North-West [Action 1]

Following the successful trial of Arch Centres in the North and South of the State, a third centre is now being developed in the North-West and is expected to open at the end of 2025. The Tasmanian Government has committed ongoing operational funding to support the continued delivery of services across all three Arch Centres.

Arch provides a safe and supportive environment for people affected by sexual harm resulting from sexual violence. At Arch, services and organisations work together under one roof to deliver coordinated, trauma-informed, and victim-centred support. Service providers include specialist counsellors, family violence workers, child safety officers, and Tasmania Police.

Exploring the Safe and Together Model for Tasmania [Action 3]

In 2024, Tasmania took an important step in exploring the Safe and Together Model, an internationally recognised, evidence-based approach to supporting families experiencing violence. As part of this work, a pilot of the CORE training was delivered in January 2024 to 40 staff from Tasmanian Government agencies. The training received positive feedback, highlighting the model's potential to strengthen service responses to family violence.

Further consideration of the model's scope, costs, and logistics is required before any decision on broader implementation is made.

Establish the Family and Sexual Violence Liaison Service [Action 5]

Since the last reporting period, a key focus has been on supporting recruitment processes for the Family and Sexual Violence Liaison Service. Recruitment has commenced for the three liaison positions dedicated to Child Safety Services, ensuring continued integration of family and sexual violence support across key sectors. Additionally, options are being explored for the three liaison positions intended to strengthen the service within the Tasmanian Health Service.

These appointments will further enhance the system's capacity to provide integrated, person-centred, and evidence-based responses to those experiencing family and sexual violence.

Supporting families through the Child Health and Parenting Service [Action 6]

The Child Health and Parenting Service (CHaPS) has embedded the provision of additional appointments for parents and children who identify as experiencing family violence as part of its ongoing practice and service offering. This system-level approach ensures that proactive and targeted interventions are consistently available to prevent and address intergenerational cycles of family violence. CHaPS continue to strengthen this practice, with, 89 additional appointments delivered during the reporting period to support families and children.

Legislative reforms [Action 8]

During the reporting period, several amendments were implemented for intimate partner or family and sexual violence legislative reform.

On 1 November 2024, amendments arising from the *Justice Miscellaneous (Commission of Inquiry) Act 2024* which support intimate partner or sexual violence legislative reforms became law. These changes included:

• A new section 430 of the *Criminal Code* 1924 and a new section 67B of the *Police Offences Act 1935,* ensure that where the prosecution tenders no evidence for an alleged family violence or sexual offence and the defendant is acquitted for that reason, the evidence that would have been led had that matter proceeded is capable of being used as tendency, coincidence or relationship evidence in subsequent court proceedings for family violence or sexual offences involving the same defendant.

• The Justice Miscellaneous (Commission of Inquiry) Act 2024 also extended the operation of section 371A of the Criminal Code to include family violence offences.

On 13 December 2024, two legislative amendments arising from the *Family Violence Amendment (Protecting People and Their Pets) Act 2024* became law. These changes included:

 An expanded definition of family violence under section 7 of the *Family Violence Act 2004* to clarify that any conduct committed, or threats made by a person regarding the potential death, neglect of, or injury to an animal that directly or indirectly intimidates, coerces or controls the persons spouse or partner; or causes mental harm to or apprehension or fear in the persons spouse or partner will be considered family violence.

On 13 December 2024, section 35 of the *Police Offences Act 1935* was amended to introduce no time limit for commencing prosecutions of indecent assault.

Trial risk assessment tool with specialist providers [Action 10]

The development of Tasmania's Risk Assessment Management Framework (RAMF) and the Tasmanian and Rural Risk Assessment (TARRA) tool advanced through targeted trials led by Engender Equality. Specialist family and sexual violence services participated in this phase, applying the tool and providing feedback.

This trial promotes consistency in risk assessment practices and will help inform alignment with emerging national principles. Tasmania's experience will contribute to national reform efforts while strengthening the local service system. The overall aim is to identify risk early, prevent harm, and enhance safety through therapeutic approaches.

Capacity building



Recognition of Safe Beds for Pets Program [Action 13]

The Safe Beds for Pets Program, operated by the Royal Society for the Prevention of Cruelty to Animals (RSPCA) Tasmania, supports Tasmanians at-risk of, or experiencing, family and sexual violence by ensuring the safety of their pets. Recognising that pets can be used as tools of control through threats and/or harm, the program establishes a coordinated network of safe bed providers and funds safe places for pets.

In recognition of the critical role pets play in the safety and well-being of individuals experiencing family violence, a \$225,000 election commitment was announced in the 2024-25 State Budget, to continue the program over three years. This funding underscores the importance of protecting both people and their pets from harm and supports the RSPCA in its ongoing efforts to provide shelter for pets affected by family violence, helping to prevent the misuse or harm of animals in violent situations.

The Tasmanian Family and Sexual Violence Alliance peak body [Action 14]

The Tasmanian Family and Sexual Violence Alliance transitioned from investigating to formally establishing itself as the peak body for the family and sexual violence services sector. The aim of a peak body is to streamline engagement between Government and the community sector and to support the sector in advocacy, policy development, and system integration through more joined-up responses. This will enable service providers to focus more effectively on delivering services to the Tasmanian community.

During the period, the Tasmanian Council of Social Services (TasCOSS) assisted in the transition process, with the Alliance moving from a steering committee to a transitional board to guide its early establishment. Formal involvement of TasCOSS concluded on 31 December 2024. The Alliance will remain in the early stages of establishment during its first 12-18 months of operation from January 2025.

During the July to December 2024 period, the Alliance successfully registered as an incorporated association. It also worked with the Government to negotiate a deed of agreement for 2025, while developing an initial work program. This included establishing governance arrangements, with a focus on developing a diverse and inclusive membership model and increasing engagement with the sector to support services for those affected by family and sexual violence.

Expansion of the Family Violence Rapid Rehousing Program [Action 15]

The Family Violence Rapid Rehousing Program is being expanded from 50 homes to 150 homes, significantly increasing access to safe and affordable housing for women and children affected by family violence. This program provides victims with accommodation in the private rental market at a subsidised rent, offering stability and support during a critical time.

This 2024 Election Commitment announcement reflects the government's recognition of the urgent need for secure housing options for those fleeing family violence. By expanding the program, the Tasmanian Government is ensuring that more families have access to the safe and affordable housing they need to rebuild their lives free from violence. These additional properties are expected to start to become available during 2025.

Prevention and early intervention



Respectful Relationships and Consent Education in Tasmanian schools [Action 24]

The Department for Education, Children and Young People has embedded Respectful Relationships and Consent Education (RRCE) as a business-as-usual practice in public schools, focusing on building sustained staff capability and fostering community engagement. In September 2024, the Department launched the 'RRCE Connect' Microsoft Teams page to facilitate statewide collaboration on the program's implementation. To support schools, a range of professional learning opportunities were delivered, including face-to-face workshops (90 attendees), online webinars (101 attendees), and self-paced training (162 participants). Key resources developed included a Roadmap for RRCE implementation, a Family and Community Engagement Package, and Curriculum Connections for Years 5-6, aligning RRCE with the Australian Curriculum.

Strengthening early intervention through the Defendant Health Liaison Service [Action 29]

The Defendant Health Liaison Service continues to strengthen its role in providing early intervention, assessment, and management services for respondents in family violence matters. During this reporting period, business processes were updated to align with legislative changes, enabling referrals to Mandatory Change Behaviour Programs. Office space has been secured within the Launceston Magistrates Court, establishing an onsite presence to improve accessibility and collaboration with court services.

The Service has also adopted the Spousal Assault Risk Assessment Guide (SARA) V2, supporting more targeted treatment planning, intervention strategies, and supervision levels based on assessed risk. Relationships with key partners, including Safe at Home, the Magistrates Court, and the Tasmania Prison Service, have been further strengthened to enable more coordinated and effective responses for respondents.

Continuing to deliver the Men's Referral Service [Action 30]

The Men's Referral Service (MRS), delivered by No to Violence (NTV), provides early intervention and rehabilitative support to perpetrators of family violence. In the reporting period, the service delivered 101 single-session rehabilitative services to Tasmanian family violence perpetrators, through direct contact and referrals from Tasmania Police.

NTV continues to offer its Early Intervention Response, where they contact perpetrators referred through police-recorded family violence incidents. This voluntary service involves cold-calling perpetrators to discuss their behaviour and offer information and referrals to appropriate support services, such as mental health or alcohol and drug interventions. Additionally, self-referrals from men seeking to address their behaviour continue to be a significant part of the service's engagement. Throughout the reporting period, NTV contacted 574 perpetrators through the MRS Early Intervention Response, providing 41 men with referrals to further services.

Voice and diversity



Ongoing establishment of Tasmania's first Victim-Survivor Advisory Council [Action 31]

In September 2024, members of Tasmania's first Victim-Survivor Advisory Council participated in induction and advocacy training to support their involvement in this vital work. This training is part of ongoing efforts to equip members with the skills and knowledge necessary to effectively engage in Advisory Council activities. The Advisory Council's inaugural meeting was held on 28 November 2024. The early focus for the Advisory Council will be on administrative and governance matters to lay the foundations for its future operations. Members are people with diverse experiences of family and sexual violence, ensuring a broad range of perspectives inform how the Tasmanian Government can improve responses and preventative measures.

Supporting Diverse Communities [Action 32]

The Supporting Diverse Communities Grant Program directed funding to community-based projects that address the unique needs of diverse victim-survivors and help reduce barriers to accessing support.

This first grant round awarded \$675,000 across seven different organisations for projects such as:

- LGBTIQA+ Family Violence Guidelines Engender Equality;
- Breaking Barriers, Building Strengths: Collaboratively Addressing Sexual Violence in Diverse Cultural Communities - Migrant Resource Centre Northern Tasmania; and
- Barriers to Reporting Sexual Assault: A Sex Industry Perspective – Scarlett Alliance.

Status of the actions

The status of the 38 actions in *Survivors at the Centre: Tasmania's Third Family and Sexual Violence Action Plan 2022-2027* are reported at 31 December 2024.

Actions carried over from the *Safe Homes, Families, Communities Tasmania's Action Plan for Family and Sexual Violence 2019-2022* have a 'Continuing' action type. These actions are considered complete for the purposes of this reporting.
